The Certified Professional in Human Factors in Health Care (CPHFH)<sup>TM</sup> is earned by professionals who have demonstrated a high level of proficiency in applying the core standards of human factors, systems thinking, and design to health care improvement.





# Why Certification is Important

This professional certification program establishes core standards for the field of human factors in health care, benchmarks requirements necessary for health care professionals, and sets an expected proficiency level.


For professionals, the CPHFH credential provides those working in human factors a means to demonstrate their proficiency and skill in the discipline.

**For organizations**, requiring the CPHFH credential provides a way for employers to validate a potential candidate's human factors knowledge and skill base, critical competencies for today's health care challenges.

## What are the Eligibility Requirements?

Candidates for the CPHFH credential are those who include human factors practices as an integral component of current or future professional responsibilities. Candidates must also possess academic and professional experience at one of the following levels:

 Diploma (e.g., associates, bachelors), plus 3 years of experience in Human Factors in Health Care Related Field over five years (either full time or part-time)

#### OR

 Master/Doctorate in Human Factors Related Field, plus 1 year of fulltime experience or 2 years of part time experience in Human Factors in Health Care Related Field over five years






#### **CPHFH Mentors Available**

#### Ready to Take the CPHFH Exam?

Register and select a date and time at a testing center near you OR choose to test virtually from your home or office with a remote proctor

#### 2.5 hour timed exam

- Time to practice before timer starts
- No scheduled breaks
- Ability to bookmark questions to return later
- On screen clock (can be turned off)
- 120 questions; 100 scored

#### Check out with proctor

 In US, internationally, and virtually: receive instant score report



## What is the passing score?

The passing score for the examination is 500. Scores ranges from 200 to 800.

You will only see your exact score if you do NOT pass the exam.

CBPPS uses a criterion-referenced methodology in scoring the certification examination. With this type of scoring methodology, there is no "curve," and candidates do not compete against one another. Instead, candidate performance is compared to the criterion of acceptable practice of a qualified patient safety professional. A statistical process called equating is used to ensure candidates are assessed using forms that have equivalent difficulty and reliability. These steps help ensure that all candidates are held to the same standard of performance. This process is used to ensure fairness to all candidates.



#### Maintaining your CPHFH Designation

3-year recertification period

Recertification may be achieved by:

- 45 credits of documented continuing education and/or other qualified activities
- Re-testing

Continuing education courses and other qualified activities must address at least one of the tested domains
