## **Maintaining your CPPS Designation**

3-year recertification period

Recertification may be achieved by:

- 45 credits of documented continuing education and/or other qualified activities
- Re-testing

Continuing education courses and other qualified activities must address at least one of the tested domains

#### PATH II: CPPS Recertification by Examination

To be eligible for recertification by examination, the certificant must sit for and pass the CPPS examination within one year prior to their certification expiration date.
