The Certified Professional in Patient Safety credential (CPPS)<sup>™</sup> is earned by professionals who have demonstrated a high level of proficiency in the core standards of patient safety by passing a rigorous and thorough evidence-based and psychometrically-sound examination.



#### **Fully Accredited**

- Certified Professional in Patient Safety (CPPS)<sup>™</sup> program is fully accredited by the National Commission for Certifying Agencies (NCCA), the accrediting body of the Institute for Credentialing Excellence (ICE)
- Provides independent affirmation that program achieves the highest quality standards in professional certification.
- Peer review process to establish accreditation standards, evaluate compliance with these standards, recognize programs which demonstrate compliance, and serve as a resource on quality certification.







Goal: identify the tasks performed and the knowledge required to be a competent practitioner


Most recent job analysis completed in 2023

#### Why Certification is Important

Establishes core standards for the field of patient safety, benchmarks requirements necessary for healthcare professionals, and sets an expected proficiency level.

**For professionals,** the CPPS credential provides those working in patient safety a means to demonstrate their proficiency and skill in the discipline

**For organizations,** requiring the CPPS credential provides a way for employers to validate a potential candidate's patient safety knowledge and skill base, critical competencies for today's health care challenges

#### The value of certification

Certification often required as a job requirement, especially in the areas of quality, risk, and patient safety.

Important credential for those in practice, academics, and/or industry

CPPS is a Magnet® recognized certification in the Demographic Data Collection Tool® (DDCT)

And of course, CPPS certification indicates proficiency in patient safety domains.

- 79% of health care professionals who have earned the CPPS told us that this credential helped them to improve patient care at their organization.
- Since earning their CPPS credential, 81% of titleholders have led organization or systemwide initiatives, leading critical improvements


#### **Certification in Academia**

Longstanding partnership with UNTHSC Texas College of Osteopathic Medicine (started in 2019) to integrate CPPS certification and patient safety education into medical education

- From small pilot study to a required course for all 3<sup>rd</sup> year medical students
- Over 1,000 students and 27 faculty certified

Opportunities beyond medical school




More than 7,000 professionals have earned the CPPS credential, representing all 50 US states and 36 countries

## What are the Eligibility Requirements?

Candidates for the CPPS credential are typically those who include patient safety practices as an integral component of current or future professional responsibilities

In addition, candidates must possess academic and professional experience at one of

the following levels:

- Baccalaureate degree or higher plus 3 years of experience (includes time spent in clinical rotations and residency programs) in a health care setting or with a provider of services to the health care industry
- Associate degree or equivalent plus 5 years of experience (includes time spent in clinical rotations) in a health care setting or with a provider of services to the health care industry



#### Ready to Take the CPPS Exam?

Register and select a date and time at a testing center near you OR choose to test virtually from your home or office with a remote proctor

2.5 hour timed exam

- Time to practice before timer starts
- No scheduled breaks
- Ability to bookmark questions to return later
- On screen clock (can be turned off)

120 questions; 100 scored

Check out with proctor

- In US and virtually: receive instant score report
- Outside US: receive score report in the mail

#### What is the passing score?

The passing score for the examination is 500. Scores ranges from 200 to 800.

You will only see your exact score if you do NOT pass the exam.

CBPPS uses a criterion-referenced methodology in scoring the certification examination. With this type of scoring methodology, there is no "curve," and candidates do not compete against one another. Instead, candidate performance is compared to the criterion of acceptable practice of a qualified patient safety professional. A statistical process called equating is used to ensure candidates are assessed using forms that have equivalent difficulty and reliability. These steps help ensure that all candidates are held to the same standard of performance. This process is used to ensure fairness to all candidates.

## Maintaining your CPPS Designation

3-year recertification period

Recertification may be achieved by:

- 45 credits of documented continuing education and/or other qualified activities
- Re-testing

Continuing education courses and other qualified activities must address at least one of the tested domains

Many of IHI educational offerings are approved for CPPS CE credit
