HIAE Key Activities

Activity	Brief Description
In-Person meetings co-designed and co-facilitated with HIAE members	<p>The Health Improvement Alliance Europe is a member-driven network. Typically, members meet in-person two to three times each year with interactive workshops, site visits, plenary presentations, and networking opportunities.</p> <p>There is a limit of three people per membership for each of the in-person meetings. We welcome and aim to honour any requests for additional spaces.</p>
Virtual Roundtables	<p>The Alliance is a responsive network offering quarterly and <i>ad hoc</i> virtual roundtable discussions, facilitated by President Emerita and Senior Fellow, Maureen Bisognano, together with members from the network. With focus on top-of-mind and current events and issues these sessions provide HIAE members with access to innovative leaders and international authorities, both in and outside of health care. There is no limit to the number of attendees from member organisations.</p>
Learning Series	<p>Led by HIAE's generous and courageous members, Learning Series calls feature topics of interest and challenge for organisations. They are time-limited, virtual, peer-to-peer learning and sharing engagements taking place over 3-4 virtual webinar calls. Learning Series topics are identified by members and offer participants strategic insights, tactical guidance, and case examples grounded in stories and examples from local context across diverse member organisations.</p>
Alliance Peer Improvers (API)	<p>A small cohort of members who come together to co-design learning visits to each other's organisations and support each other's professional development and strategic objectives.</p>
IHI/BMJ International Forum, Europe, and IHI National Forum, USA	<p>Networking receptions are held at both of these annual conferences</p>

Additional opportunities and activities are designed with and shared with the HIAE members over the course of the year. The IHI team welcomes new ideas and encourages all members to share their feedback and improvement ideas openly and frequently.

Pedro Delgado, MSc, is Vice President for the Europe Region at the Institute for Healthcare Improvement (IHI). Before joining IHI in 2010, Pedro held roles in hospital management and large-scale improvement in the UK and gained experience in mental health services in both Venezuela and the UK. Based in the United Kingdom, he has played a pivotal role in IHI's global expansion. Pedro has led the design, implementation, and senior partnerships for large-scale health system improvement initiatives across the world. His work spans efforts to reduce C-sections and healthcare-associated infections in Brazil and other Latin American countries, improve early childhood education in Chile, enhance patient safety in Portugal, and advance mental health services in London. He is a trusted coach to senior leaders and teams, and is a frequent international lecturer on large-scale change, patient safety, and quality improvement. Pedro also serves as an Instructor at the Harvard T.H. Chan School of Public Health, a Senior Atlantic Fellow for Health Equity, and an Associate Editor of *BMJ Leader*.



Susan Hannah, MS, is Senior Director for the Europe Region at the Institute for Healthcare Improvement (IHI). Based in the UK, she brings a strong clinical background in high-care nursing, combined with extensive expertise in quality improvement and leadership across both acute healthcare and community-based population health. Susan has led significant safety and quality initiatives, including the delivery of a health system-wide patient safety programme. During her six years with the Scottish Government, she held key improvement and leadership roles, helping to embed quality strategies and improvement science into government policy, public services, and the non-profit sector. She was the lead for the Children and Young People Improvement Collaborative—a complex, large-scale national programme supporting multi-agency communities to improve health outcomes and enhance life chances across Scotland. At IHI, Susan's work spans delivery of multi-year partnerships, teaching education programmes, and collaborative networks throughout the Europe region.



Andreia Cavaco is a Project Manager at the Institute for Healthcare Improvement (IHI), with extensive experience in managing quality improvement initiatives across the UK, Brazil, and Spain. Since 2015, she has led regional and national projects within the UK's National Health Service (NHS), holding senior project management roles focused on healthcare improvement. Andreia joined IHI in May 2022 and has since held cross-functional roles. In 2023, she became the project manager for the Health Improvement Alliance Europe (HIAE) and has contributed to IHI's Global Education work. Currently, her focus is on the Europe region, where she supports the Chief Quality Officer UK education programme and delivery of the BeaMom pilot project which aims to prevent and support postpartum depression within Portugal's National Health System—bringing her passion for maternal health to her home country.



Shelby Reed is an Associate Project Manager at the Institute for Healthcare Improvement (IHI), where she contributes to healthcare transformation initiatives across Europe. With a strong background in NHS project leadership and operations, she brings expertise in stakeholder engagement, data-driven improvement, and strategic coordination. Prior to joining IHI, she held several leadership roles at University Hospitals Bristol and Weston NHS Foundation Trust, leading multidisciplinary teams and managing trust-wide improvement programmes.



Maureen Bisognano is President Emerita and Senior Fellow at the Institute for Healthcare Improvement (IHI), where she previously served as President and CEO for five years, following 15 years as Executive Vice President and COO. A recognised leader in healthcare improvement, she was elected to the National Academy of Medicine (formerly the Institute of Medicine) in recognition of her contributions to the field. Maureen advises healthcare leaders globally and is a sought-after speaker at major conferences on quality improvement. She is also a passionate advocate for meaningful change in health systems. In addition to her role at IHI, she is an Instructor of Medicine at Harvard Medical School. She chaired the Advisory Board of the Well Being Trust, co-chairs the Massachusetts Coalition for Serious Illness Care alongside Dr. Atul Gawande, and serves on the boards of the Commonwealth Fund, Indiana University Health, and Nursing Now. Before joining IHI, Maureen was CEO of the Massachusetts Respiratory Hospital and Senior Vice President at The Juran Institute.



Professor Jason Leitch, CBE Jason is an international expert on health care quality, systems improvement and crisis communications. He is a Director of Leitch Health Ltd. Jason is a Senior Fellow at the Institute for Healthcare Improvement, the US based global organisation responsible for health systems improvement around the world. Jason has advised countries including Sweden, Norway, Denmark, Australia, Singapore, UAE, Canada and many others. He was appointed CBE in the 2019 Queen's Birthday Honours. He has a doctorate from the University of Glasgow, a Masters in Public Health from Harvard and is a fellow of the three UK surgical Royal Colleges. He is an internationally recognised speaker and adviser on health and care improvement, public health and crisis communications
